## **Information bulletin for Admission to PC&PNDT Training 2025 (Fundamentals in Abdomino- Pelvic Ultrasonography)**

### **Programme Details:**

The Six months training programme will be conducted as per the provisions under Six Months Training Rules, 2014 and as amended 2020 under PC&PNDT Act at the notified 19 institutes in GNCT of Delhi. A total of 44 seats are available for the present session.

Training Fee: ₹20,000 {payable to State Appropriate Authority (SAA), PC&PNDT, GNCT Delhi}

Application/Counselling Fee: ₹2,500 payable online to Guru Gobind Singh Indraprastha University (GGSIPU)

**Training syllabus and curriculum: As per the Six Months Training Rules, 2014 under PC&PNDT Act and as amended in 2020.**

### **Counselling /Admission Process**

#### **1. Notification and Registration**

Candidates must complete the registration form in physical mode, as available on the Website of Health and Family Welfare, Department of H&FW, GNCTD <http://health.delhigovt.nic.in>, DSHM <https://dshm.delhi.gov.in>, 'PC&PNDT' <https://pcpndt.delhi.gov.in> and GGSIPU [www.ipu.ac.in](http://www.ipu.ac.in) and submit the application form along with all supporting documents to the office of Dean, USM&AHS, Room No E-404, Guru Gobind Singh Indraprastha University (GGSIPU), Sector -16C, Dwarka, New Delhi- 110078.

An application & counselling fee of ₹2,500 is to be paid online and a copy of the payment slip should be attached along with the application form.

#### **4. Eligibility criteria**

- (1) Any registered medical practitioner shall be eligible for undertaking the said six months training programme.
- (2) The existing registered medical practitioners, who are conducting Ultrasound procedures in a Genetic Clinic or Ultrasound Clinic or Imaging Centre, on the basis of one-year experience or six months training, are exempt from

undertaking the said training, provided they qualify the Competency Based Assessment (CBT) as specified in schedule II.

- (3) If a medical practitioner fails to clear the said Competency Based Assessment conducted by **State Appropriate Authority**, PC&PNDT, GNCT Delhi, after three attempts, he/she shall have to undertake the six months training programme, as provided under these rules, for the purpose of renewal of registration.

## 5. Categories of candidates who can apply are as under:

**Category 1:** Candidates already registered under PC&PNDT but have not cleared the Competency Based Test in 03 attempts.

The criteria for selection of candidates in category 1 will depend upon the marks obtained in the third attempt of CBT.

**Category 2:** Candidates who apply afresh on the basis of merit of NEET PG 2024.

Allocation of seats will be for candidates who have passed MBBS from Medical colleges in Delhi only. The criteria for selection of candidates in category 2 will depend upon NEET PG 2024 score/rank obtained.

**Category 3:** Candidates who are **In service Regular candidates**.

The In- service seats will be allocated to the candidates who are serving under the Delhi Health Services, GNCTD. Candidates are required to qualify NEET PG 2024. The criteria for selection of candidates in category 3 will depend upon NEET PG 2024 score/rank obtained.

## 6. Number of seats

Total seats - 44 seats

16 seats are for category 1; and 28 seats are for categories 2 & 3

5 % of total seats are reserved for PwD candidates across all categories.

The vacant seats if any in category 3 will be filled by eligible candidates of category 2.

The vacant seats if any in category 2 will be filled by eligible candidates of category 1.

## 7. Conversion of seats

The conversion of seats will be carried out in the second round of counselling as per MCC counselling rule for NEET PG 2024. The said conversion will be done only when the candidates belonging to said category remain vacant.

## 8. Scrutiny and Merit List:

Applications received will be first scrutinized by the State Appropriate Authority. This will be followed by scrutiny by the constituted committee. The criteria for eligibilities will be considered, and a Merit list will be prepared. Candidates with missing or incomplete documents will be notified for correction by Email and submission must be done within 3 days.

Candidates will be ranked based on their CBT marks/ rank in NEET PG 2024.

A provisional merit list will be published on the website of Health and Family welfare, Department of H&FW, GNCTD <http://health.delhigovt.nic.in> and GGSIPU [www.ipu.ac.in](http://www.ipu.ac.in)

## 9. Counselling Rounds:

Number of applicants called for counselling will depend upon the number of applications received.

Counselling sessions will be conducted in two rounds at the designated venues at Dwarka campus, GGSIPU.

Candidates must appear in person for counselling and bring original documents for verification.

Based on their rank in the merit list and preferred choice, the candidates will be allotted seats in one of the 19 designated Institutes. The merit list with allotted institute will be prepared by GGSIPU, and final list of admitted candidates in various institutes will be handed over to the State Appropriate Authority.

The candidates are required to pay a training fee of ₹20,000 to the SAA in the form of a Demand draft in favour of **State Appropriate Authority, PC&PNDT, GNCT of Delhi**, following which Seat will be allotted.
