Minutes of Meeting

A meeting of the **State Task Force Immunization (STFI)** was conducted under the Chairmanship of Special Secretary (H&FW) / MD DSHM, on 5th December 2023 (Tuesday) at 3:30 pm, in the Conference Room-3, Level-2, Delhi Secretariat. The meeting was attended by Director (DFW), officials from Revenue, Education, Medical Colleges, Delhi Metro, ESIC, CGHS, WCD, Railways, along with Officials from DFW and DSHM, Govt. of NCT of Delhi and representatives of Development Partners.

The meeting initiated with SEPIO briefing the Chair on the various stakeholders attending the STFI meeting. SEPIO then briefed the gathering on the National and Delhi achievements with respect to Polio Programme. Further, the earlier organization of Pulse Polio NID / SNID was briefed, followed by the new organization of the same under the Decentralization Mode of Pulse Polio at the level of the district. Further, the details of activities to be conducted at Polio Booth Kendra and Polio House-to-House activities were also detailed, along with roles and responsibilities of the involved manpower at all levels. Role of Partners Agencies viz. WHO and UNDP and other Participating Agencies / Departments were detailed to all attendees. The involvement of Delhi Metro (DMRC), Cold Chain Flow and Vaccine Distribution was briefed by SEPIO. Activities / Details of IEC, Logistics and Transport were also detailed by SEPIO.

Director (DFW) reiterated the need of efforts for IEC and Mobilization at Transit Sites like Bus Depots, Railways, Delhi Metro, Religious Places etc. Further, display of IEC at all AAMCs was also stressed upon by her.

It was followed by brief on the activities under MR Elimination Status by SEPIO, including NMNR Rate, Sample Collection, etc. Some districts highlighted the issues regarding availability of Sample Collection Kits for Fever and Rash Surveillance under MR Elimination Agenda.

A short presentation by SMO WHO followed briefing on the Global Polio Case Status, and Statistics related to Sewage Surveillance Sites, Non-Polio AFP Rates and Stool Adequacy of Samples. Further, the percentage of unimmunized children and summary of reason analysis for the missed areas was presented for the May 2023 Pulse Polio Round. Current Status of DTFI and Workshops held in each district and Status of Microplanning in the Districts for SNID were also presented. SMO WHO also emphasized for focus on Missed Areas during the round and activities for MR Elimination.

The following directions/observations were made by the Chairperson / MD DSHM for further urgent necessary action:

- 1. Polio Booths / Camps at Delhi Airport to be organized, in coordination with GAAR / AAI / APHO (Action: State & New Delhi District)
- 2. Issue appropriate communication for involvement of Telecom Operators, Electricity Department and Delhi Jal Board. (Action: State & all Districts)
- 3. Creatives / IEC Material for Pulse Polio to be given to MCD, for display at relevant sites. (Action: State & all Districts)
- 4. All RWAs and Religious Bodies to be contacted and sensitised by all districts. (Action: All Districts)
- 5. Audio Message to be provided to Delhi Metro, DSHM / DIOs and MCD for playing the same in Delhi Metro premises / trains, VBSY Vehicles / Sites, and Dumper Tippers. (Action: State & all Districts)

- All districts to prominently display IEC Material at all relevant locations and at all transit 6. points / high footfall & prominent visibility areas. (Action: All Districts)
- 7. All districts to ensure achievement of NMNR > 4 individually and, Sample Collection > 80% in Fever & Rash Surveillance, focussing on achieving MR Elimination by December 2023. (Action: All Districts)
- 8. MCV-1 and MCV-2 Coverage to be universally maintained at >95%, for achieving MR Elimination by December 2023. (Action: All Districts)
- 9. Letter to be issued to all agencies (including CGHS, Railways and ESIC) and facilities (of Delhi Govt., and MoHFW, Gol), for Inactive Delivery Points / Vaccination Sites on U-WIN Portal. (Action: State & all Districts)
- D.O. Letters to be issued to Cable Operators Association, Delhi Building and Other 10. Construction Workers Welfare Board and APHO and involve them in the Pulse Polio SNID Round. (Action: State & all Districts)
- Sewage Sites for Pulse Polio Surveillance to be updated in view of settlements of refugees from Pakistan and Afghanistan, and consider inclusion of areas of Wazirabad, Majnu Ka Tila and certain areas in South-East District. (Action: State & WHO)
- Press Note to be provided / issued to all Media Personnels for wide dissemination of the message. (Action: State & all Districts)
- Staff from St. Johns Ambulance may be hired as per norms in the districts, if needed. No volunteers to be included and all hired manpower to be on boarded on the iDIGIPAY / SNA Account platform. (Action: All Districts)
- DMs to issue communication to Honorary Secretary, Indian Red Cross Society, for support of trained manpower from the organization, as suggested by Director (DFW). (Action: All Districts)
- 15. DMs and CDMOs to arrange for Launch Events in all districts on SNID (10th December 2023). (Action: All Districts)
- 16. It was desired by MD DSHM that no area is to be left uncovered. Therefore, the uncovered areas of Kailash Nagar, Dharampura and the health facility of CGHS at Krishna Nagar, which fall under the revenue boundaries of Shahdara, will be covered by Shahdara District for RI & IPPIP (Action: Shahdara District)

Director (DFW) urged full cooperation from all the Stakeholders for successful completion of the upcoming SNID round in Decentralized Mode.

Special Secretary (H&FW) / MD DSHM concluded the meeting directing all districts for massive IEC efforts and involvement & sensitization of all relevant stakeholders, thus achieving seamless decentralization of NID / SNID under IPPIP. Furthermore, MD DSHM directed all districts to use the SNID Round as an opportunity for check listing the activities under MR Elimination.

The meeting ended with thanks to all participants.
