Minutes of Meeting

A virtual meeting of Nodal Incharges & Medical Officer Incharges DGDs ,AAPC's, SPUHCs , MCWs centres, Maternity Homes, CGHS Health Centres, ESI Hospital and Dispensaries, Railway Health Unit and Family Planning Nodals of Hospitals (SGMH, BSAH, BMH, DCBH) was held on 19.07.23 from 12:00 Noon onwards regarding review of WPD 2023 campaign.

The meeting started with welcome of all participants.

The following points / agenda were discussed & are as follows:-

1. All the participants were instructed to do the daily reporting.

- 2. CDMO (NWD) instructed all the Nodal Officers to sensitize more eligible couple to avail family planning
- 3. CDMO (NWD) instructed all MOI/Cs to increase screening of anaemia & in all the age group and give appropriate management with dietry advise.

4. Instructions were given to all MOI/Cs to celebrate more Adolescent health day & AFC.

- Sensitization to all the MOI/Cs about MCP card were done & instruction issued to all the MOI/c to train their ANMs & ASHA workers and also ensure the MCP card should be properly filled and none of the columns to be left blank.
- 6. DPO (RCH) apprise about the addition of newer contraceptive (SCMPA) into the Family Planning basket.
- Sensitization about upcoming NDC was done and instruction were issued to all the MOI/Cs to do microplanning for upcoming NDC.
- 8. DPO (RCH) requested all the MOI/Cs to actively participate in WPD campaign competition like poster, quiz, slogan and other activities.

9. DPO (RCH) instructed all the MOI/Cs to make an Anemia corner in each and every health facilities with

proper IEC material (Action: MOI/C & ANMs) 10. All the Maternal deaths occurring in the catchment area of health facilities either home death or hospital death, in both the condition, verbal autopsy is to be done mandatorily and same is to be uploaded on the MPCDSR portal in time bound manner. (Action: MOI/Cs, ANMs & CDEOs)
