

MOU/MOA/Contracts Entered With Other Entities

1. A MoA (Memorandum of Agreement) is in place between “Delhi State Health Mission, Govt. of NCT of Delhi” and “United Nation Development Programme”, which has been extended till the period of 31st March 2026, for implementation of Health System Strengthening Interventions, as mandated by MoHFW, GoI, which include e-VIN platform (including Temperature Loggers), U-WIN Portal, and Co-WIN Portal.
2. A tripartite MOU for continuation of COE (Center of Excellence)-EIC (Early Intervention Center) under RBSK, NHM, between State Health Society of Delhi, Dean (MAMC) and MD (Lok Nayak Hospital) is in place w.e.f. 1st April 2024 till 31st March 2026.
3. MOU for continuation of Mission NEEV program (Comprehensive Newborn Screening program under RBSK, NHM), running in project mode in Delhi, between State Health Society of Delhi and Dean, Maulana Azad Medical College, is in place w.e.f. 1st April 2024 till 31st March 2026.
4. MOU for continuation of DEIC (District Early Intervention Center) under RBSK, NHM at Swami Dayanand Hospital, between State Health Society of Delhi and Director Hospital Administration, Municipal Corporation of Delhi, is in place w.e.f. 1st April 2024 till 31st March 2026.
5. MOU for DEIC (District Early Intervention Center) at Chacha Nehru Bal Chikitsalaya between State Health Society, Delhi and Chacha Nehru Bal Chikitsalaya, for continuation of DEIC under Rashtriya Bal Swasthya Karyakram, National Health Mission, Extension of MoU w.e.f. 10/01/2026 for a period of 24 months for continuation of DEIC at CNBC under RBSK, NHM, remain in force till 24 months or completion of project/ program whichever is earlier and can be extended for a period as may be approved by GoI.
6. GeM Contract with Phonomax India for Printing and Photocopying Service for Rs 30240/- for a period of one year w.e.f. 28.7.25 from GeM portal.
7. GeM Contract with Pinnacle Enterprises for AMC of 17 computers @ Rs. 2,006/- for a period of 01 year from GeM portal was valid upto 5.10.25.
8. Rate Contract provided by the Transport Department, GNCTD, accordingly DFW has entered with L.R. Taxi Services for Three vehicles on rental basis @ Rs. 1,80,000/- from 01-04-2023 to 31-03-2026.
